











## Disciples of Christ Immigration Response Specialist

## Fulfilling God's Call to Welcome, Support, and Advocate for Immigrant Communities

Program Report Date Period: January – March 2020

Background of Program: Three Disciples organizational entities of the Central Pastoral Office of Hispanic Ministries, Disciples Refugee & Immigration Ministries, and the Christian Church Capital Area joined together to develop, hire, train, and support an "Immigration Response Specialist" (IRS) for the Christian Church (Disciples of Christ). Leaders from the three organizations to the partnership include Rev. Lori Tapia, Rev. Dr. Sharon Stanley-Rea, and Rev. Allen Harris. The IRS works to increase the capacity within the Christian Church (Disciples of Christ) to fulfill God's all to walk alongside, support, and advocate with affected immigrant communities against growing anxieties, family separations, and injustices which, if not addressed, can continue to negatively impact generations to come. The position is full-time, and initially funded by Week of Compassion for 18 months. Valeria Bejar was hired to fill the position, and began work in late June of 2019.

The Immigration Response Specialist position provides intensive, intentional direct action with congregations and immigrant led community partners which aims to increase awareness, equip congregations and individuals, and increase outreach to immigrants; creating long-term change for addressing critical and emergent needs for refugee/immigrant families and individuals. It also helps to prepare and grow congregations to be "Immigrant Welcoming Congregations," as approved at the Disciples General Assembly 2017 through GA-1723. The Specialist provides intensive outreach to congregations to increase the number of congregations and individuals who are now actively engaged in accompanying, supporting, and advocating with families and individuals negatively impacted by the immigration crisis and facing potential family separations and deportation. The Specialist has knowledge; through both information and personal experience, of current immigration policies and challenges. The specialist has deep experience working with immigrant and refugee communities, is competent in advocacy/community outreach/organizing, and is fully bilingual (English/Spanish) with the ability to read, write and communicate verbally.

In the program MOU among partner agencies, key responsibilities are assigned as follows:

+Refugee and Immigration Ministries: Rev. Sharon Stanley-Rea, Director of RIM, will be the direct supervisor for the Immigration Response

Specialist, working consistently with the Specialist to provide policy updates, develop action resources, and generate and support congregational strategies for response.

- **+CPOHM:** Obra Hispana will serve as the fiscal agent for the program, maintaining financial records through Treasury Services and will also serve as the formal employer of the Immigration Response Specialist.
- +Capital Area Region: The CCCA will serve as liaison to the College of Regional Ministers, informing the Regions and Regional Ministers of the work of the Immigration Crisis Response Specialist and promoting support for refugee/immigrant families and individuals across the Regions of the CC(DOC).
- **+Week of Compassion:** Week of Compassion will provide funding for the program through December 2020 via reimbursement to CPOHM, based on monthly invoices submitted to Week of Compassion through Treasury Services by 15<sup>th</sup> of each month.
- +RIM, Obra Hispana, and the CCCA will maintain regular communication for the coordination, promotion, and evaluation of the work of the Immigration Response Specialist. +All partner ministries will promote the work of the Immigration Response Specialist through their networks and encourage participation among congregations and individuals.

A full "Planning Retreat" with Valeria, attended by CPOHM's Lori Tapia, RIM's Sharon Stanley-Rea, and CCCA's Allen Harris (remotely attended) was held in Phoenix on January 9-11, in order to envision and plan key work for the quarter. In this retreat, we reviewed with Valeria her work through the past quarter, discussed challenges encountered, planned focus actions and congregational priorities in Valeria's future work, and determined additional planning dates.

The team continued serious conversations, carried forward from previous discussions, where we determined that the language of "Immigrant Welcoming Congregations" was itself non-inclusive, and communicates paternalism in ways unhelpful and unintended. Some immigrants have likewise shared with the Immigrant Response Specialist that they are not interested in having a structure that "labels" any congregation as "welcoming." Rather, they expressed a hope for a deeper transformation and partnership. Throughout the coming months of the grant, Valeria will continue congregational engagements that seek transformed relationships, that are deeply committed to elevating immigrant experiences, and that will intentionally listen with other immigrants for a vision and characteristics of types of transformation desired by, and led by, immigrants.

RIM continues to provide regular supervision with the IRS. A check in with all three partners will is held approximately monthly. A next Planning Retreat with Valeria with CPOHM/CCCA/RIM will be held as pandemic travel allows, in the months ahead. Next reports will cover the time periods of Apr-June 2020, July-Sept 2020, and Oct-Dec 2020, and will continue to reflect upon the three main goals of the grant. Updates for each goal are below:

Goal 1: <u>Increase Awareness</u> that prepares our congregations to build the spiritual practices, healing, knowledge, and partnerships necessary to grow the "Immigrant Welcoming Congregations" movement, and to strengthen our collective voices and commitments to relationships and work for justice with immigrants.

- Launched campaign in partnership with Refugee & Immigration Ministries in support of the ICE arrest of Arizona faith Leader, Ramon Bejar. A total of 536 signatures were collected, representing D.O.C congregations from 30 different states including Iglesia Todas las Naciones from Mexico. <u>Ramon Bejar Support Letter</u> (January)
- Released a serious of RIM Wraps (in partnership with Refugee & Immigration Ministries) with updates on Ramon Bejar's case, informing congregations of status of his case and potential outcomes. RIM WRAP Re: Ramon Bejar
- Attended the CC(DOC)'s General Board & Administrative Committee Meeting. During my participation in certain workshops and activities, I shared the ministry's work with multiple different Regional Ministers.
- While at the General Board meeting, I also reconnected with Rev. Nadine Burton, Regional Minister of the Great River Region. She updated me on actions her region took during the Mississippi Raids, following our IRS encouragement and support: <u>The Great River Region: Letter to U.S Senetaros in AR, MS, LA</u> <u>The Great River Region: Congregational Letter</u> (Feb. 21 25<sup>th</sup>)
- Co-Facilitated the very first Anti-Racism Pro-Reconciliation training in Spanish, alongside Rev. Bob Howard, Rev. Pedro Ramos-Goycela and Regional Minister, Jay Hartley. During this training the region of Arizona and its Convencion pastors, were able to look at racism and systems that directly affects the immigrant, Latinx communities. Through this training the community also engaged discerning scripture, and how the word calls us to dismantle systems and institutions of oppression. (Feb. 29<sup>th</sup>)
- Participated in the creation of the IIC #Faith4DACA Lent Devotions. Here I was able to share how my family, church, and community would be impacted if DACA protections were removed. - Worked alongside the IIC, and the United we Dream Organization, to present a webinar informing the community of where DACA stands now, how to engage as a faith community, calls to action, and resources. Webinar Recording Re: #Faith4DACA March 10<sup>th</sup>)
- Collaborated with the Conference of Major Superiors of Men, as a panelist for their national gathering of Catholic religious justice and peace leaders. As a panelist, I shared alongside Linda Green, Professor Arizona Univ., and Alyshia Galvez, professor at The New School in NYC. - Initiated development of an Immigrant-based workshop for the Wild Woman of the West Conference Scheduled for June 12<sup>th</sup>- 14<sup>th</sup>. (changes TBD based on COVID-19)
- Developed an immigration Workshop for the annual Hispanic Regional Texas Women's Conference. This workshop focused on the story of Ruth and its Immigration footprint. (Conference was subsequently postponed due to COVID-19.)
- Developed IWOBS (Immigrant-led weekly Online Bible Study) an online study that will share and deepen the understanding of scriptures through an immigrant-based Lens. Goal 3: **Expand the outreach** to and accompaniment with affected refugee and immigrant families and individuals experiencing separation due to detention or deportation.

  with their renewals. United We Dream Renewal Fund.
- Congregations were encouraged to utilize the IIC #Faith4DACA <u>Lent Devotion</u> to equip themselves with scriptural context and resources to assist DACA recipients in this time of uncertainty.
- Due to the transition of Disciples Immigration Counsel, no one new was previously referred during this grant period.
- Attempting to provide resources to the children of Ramon Bejar (AZ Hispanic convention, Regional Moderator,) during this time of separation.
- Increasing support to all DACA Recipients awaiting SCOTUS decision. By promoting a Mental Health/ Self-Care segment in the upcoming #Faith4DACA Webinar RSVP. This segment will be led by Rev. Hector Hernandez, and Rev. Bere Gil-Soto.
