Approval of Minutes from Fall 2019 WoC Board Meeting:

Discussion:

- EDIT to Fall 2019 Minutes: Remove Patice Holland from attendance; add Judi Frost to the attendance
- Cindy lifted up the point in minutes regarding self care for staff. The Executive Committee will continue that conversation as staff lives into the uncertainty and new patterns of this moment.
- Cindy and Vy noted that there were several policy discussions at the last meeting; those conversations are ongoing. Brief discussion of the importance of policies during times of economic uncertainty.

# Executive Director's Report- Vy Nguyen

Vy highlighted some key items in his report and changes in the global context since the board received the report: child mortality, food, disaster complications, refugee concerns. Working closely with other General Ministries.

#### Discussion:

- Brief update on refugee and immigration ministries, DHM, and the impact of COVID-19 on refugee and immigration issues.
- Discussion of impacts of COVID-19 on domestic work, staff roles, and organizational structures and patterns.

2019 Unaudited Financials and 2020 YTD Financials- *John Goebel presented the financial reports.* 

Discussion: No questions on 2019 Statement of Financial Position

- Majority of funds held at CCF are in Beasley Fund--Gary notes that the Beasley Fund was up 9% in April
- Vy: COVID-19 responses so far have come from the Compassion in Action line (undesignated). Noted the uncertainty of giving from now into 2021, and highlighted efforts to improve online and mobile giving options.

### Operating Reserve Policy

Discussion: Gary presented background information on the development of this policy, including ways he tested the policy against potential scenarios of loss. Gary noted the policy establishes a net asset balance target that would sustain Week of Compassion through 6 months. Reserves would be held in Church Extension notes, so they are less market sensitive.

Cindy asked about how this compares to other ministries' policies. John G:
 OGMP has a policy, but because so many partners rely on Week of Compassion support, it is appropriate to have a higher amount.

Update on DOM/WOC Dialogue - Cindy Kim and Milca Rivera

Discussion: Cindy provided some history, context, and places of intersection for the two ministries. Milca gave an overview of the meeting in January. Noted the shared values, mission and vision of the two ministries. Came out of the meeting with a

commitment to work together, to develop Memoranda of Understanding for SDG proposals and the GMI program, with drafts begun before fall Board Meetings. Also decided to have Board representatives at each other's Board Meeting once a year.

Sustainable Development Proposals - Jake Caldwell, Judi Frost and Milca Rivera

Discussion: Jake reviewed the summary document compiled by the team. Discussion of the impact of COVID-19 on all projects and of typhoon Vongfong on the project in the Philippines. Celebration of the shared funding represented in several programs, as well as the instances of sustained relationships with partners we have supported in the past.

 Vy highlighted that the only ecumencial proposal we received was from Ag Mission, since it directly addresses the COVID-19 pandemic. We did not solicit proposals from other ecumenical partners given the uncertainty of development projects in COVID environment.

Motion: Approval of grant applications as recommended by the committee.

#### COVID19 Response Proposal

Discussion: Vy presented the <u>proposal document</u>: requesting up to \$800,000 from the unrestricted reserve in addition to funds available in the Compassion In Action fund. The staff are working to balance responding to COVID-19 while setting aside enough to continue responding to emergent disasters.

Rebecca asked about Board approval for use of undesignated funds. Vy noted that the previous standing rules included a policy, but the current standing rules do not have a limit as such. Rebecca requested that Vy communicate with Board members when he sends out disbursements to enable Board members to be good advocates. Vy: the general information is in the email newsletter (the responses map), and staff can provide the detailed spreadsheet of responses to the Board on a monthly or bimonthly basis.
