Jake Caldwell called Meeting to Order at 10am Eastern
Welcome and Introductions - Jake Caldwell, Chair

Opening Devotion - Patice Holland -- Turning our grief to joy (John 16:16-33)

Business Session

Approval of Agenda -ACTION-

Cindy moves to approve agenda as shared; Claretta seconds Approved unanimously

Approval of Minutes from Fall 2020 Meeting -ACTION-

Kris moves to approve minutes as presented; Patice seconds Approved unanimously

Executive Director's Report - Vy Nguyen

- Vy highlighted some of the areas of extreme impact from the pandemic, including Gaza, which is additionally affected by the recent violence. He noted the ways Week of Compassion is restructuring domestic responses, including taking on coordination of disaster recovery volunteering.
- Caroline shared in more detail about domestic priorities.
- Discussion included questions about challenges for disaster preparedness framework, especially regarding language access, diversity of Regional capacities, and connections with Racial-ethnic ministries.
- Vy elaborated on the Oreon E. Scott grant; Bill encouraged Week of Compassion to move forward with evaluation/audit regardless of the outcome of the grant.
- Cindy inquired about the outcome of the special appeal for COVID-19 response in India.Vy noted it will take another month to get a good sense.
- Erin offered a brief review of the Mobile Giving platform and anticipated changes to materials for the 2022 Offering.
- Jake moves to accept Vy's report; Milca seconds Approved unanimously

Approval of Standing Rules - ACTION -

- Kris Culp presented recommended changes to the Standing Rules regarding Executive Director transition and enumerating existing responsibilities and functions of the Executive Committee.
- Cindy moves to approve the Standing Rules as revised; Judi seconds
 Approved unanimously

Review of Financials -

- John Goebel reviewed the 2020 Financials and YTD April Financials
- He highlighted the healthy financial position of the ministry.
- John noted the receipt of the Payroll Protection Plan (PPP) loan, explaining we
 did not qualify for the 2nd round of PPP funding. Forgiveness on this loan is in
 process and expected.
- The 2020 audit was not available at the time of the meeting, but John shared that
 the day before the audit committee received the audit -- a "clean opinion"-- which
 they voted to submit to the Administrative Committee. The Board of Stewards will
 receive a copy of the audit after Administrative Committee approval.

Updates from the Field- Conversation with Partners

- Vy welcomed Peter Makari, <u>Area Executive for Middle East and Europe.</u> Global Ministries, Riad Jarjour, President of FDCD, and <u>Leda Zakarison.</u> GM Global Mission Intern with FDCD
- Partners highlighted the ongoing partnership with Week of Compassion through Global Ministries, noting especially the support for refugees. They emphasized

the compounding challenges of the Syrian war, COVID-19, other regional conflicts, the 2020 explosion in Beirut, and the need for peace-building.

Spring Sustainable Development Reports and Proposals - ACTION -

Committee (Judi, Milca, Claretta, and Patice) presented the <u>sustainable</u> <u>development reports</u>.

Judi presented summaries of the 2021 Sustainable Development Proposals, with the recommendations of the committee:

- West Africa Initiative (Ag Missions): food security and GBV prevention
 - Seeking \$20,645 of the \$60k+ fully funded budget
 - Recommendation: fund full request
- CWS, <u>Child Protection in Bosnia and Herzegovina</u>: protection of unaccompanied migrant children
 - Seeking \$25,000 of \$130,000 budget
 - Recommendation: fund full request
- Global Ministries, Christian Council of Ghana: Hope for Teen Girls
 - Budget did not align with stated goals in proposal, and the subcommittee had concerns about use of funds based on Spring 2021 narrative report.
 - Seeking \$7,000 of \$12,000 budget
 - Recommendation: decline support at this time
- Global Ministries, <u>Organization of African Instituted Churches</u> (Kenya):
 GBV reduction and economic independence for women.
 - Seeking \$10,000 for \$10,000 budget
 - Recommendation: fully fund request
- Global Ministries, <u>FEDICE</u> (<u>Ecuador</u>): Women's microcredit project
 - Seeking \$8,000 of \$35,000 total budget
 - Recommendation: full fund request
- The Committee moves the Board receive the Spring 2021 reports and approve funding for Spring 2021 proposal as recommended; Kris seconds.
