This grant in Spring 2020 provides an initial investment for resources to promote community development through agricultural sustainability. This project is comprised of three main actions: corn production, bean production and raising laying hens.

Hurricanes Eta and Iota struck this region of Honduras on November 3 and November 16, 2020. These catastrophic storms affected the valley, mountain, and coastal regions of Honduras. As priorities were shifted to emergency responses, the IERH needed to postpone and restart the planned work of the project as many of the original proposed sites for this work were flooded. The project has resumed and will be using a mixed crop of corn and plantains.

Primary Activities Implemented / Implementación de Actividades Primarias

1. Currently, an acre of corn has been planted and is currently being cultivated in the area of Rio Chiquito. The first fertilization of these crops has been applied and they are now in a weeding and pest control phase.
2. In the summer of 2021, the IERH will work with participants to plant two more acres of corn. Additional work will begin to develop a plantain crop. Plantains were selected because they will grow well in the selected area and are profitable to sell at market. While plantains are developing, the same area can be used to grow at least two harvests of corn.
3. The poultry project was started and the land was prepared for chicken coops before hurricanes Eta and Iota. After the hurricanes, the work was then halted because the land was completely flooded. A new property has been identified and materials are being acquired to build chicken coops there. The IERH is in process of acquiring chickens for this portion of the project.

Hurricanes Eta and Iota created major challenges and delays for this project. They caused major damage and flooding which made land unsuitable for cultivating crops and raising livestock. The hurricanes also created several other critical issues for affected communities which more immediately demanded attention in those areas. To adapt and work towards the goal of this project, the project was paused while a new plan was put in place. Additionally, new, less impacted land was identified, and plans are set to cultivate crops which would grow well in this new context.
