The goal of this project has been to provide working capital for the 20 participating families, who wish to carry out agricultural or commercial work such as dairy farming, onion farming, or food sales. The grant funding from Week of Compassion was requested to purchase the raw materials, merchandise, seeds, and livestock, which will be cared for by participating families for an income-generating opportunity.

Primary Activities Implemented / Implementación de Actividades Primarias

This new microcredit group went through the successful FEDICE microcredit model, which has been implemented in other communities. Activities that took place over the beginning months of the project include:

- Monthly training sessions on topics related to the technical needs of the project and dialogue on agriculture and livestock rearing.
- Increasing the financing sources through the re-investment of a portion of the revenue generated by the project.
- Periodic monitoring and participatory evaluations, followed by corrections or improvements implemented to ensure success for all families.
- Projects of the 20 participating families were started. Eleven (11) families began raising cattle and providing the necessary shots and medications, four (4) families began raising sheep, and five (5) families began small shops to sell items such as stationary, internet, diapers, clothes, or agricultural products.

My name is Josefina Herrera, and I belong to the Planchaloma women's group. Thanks to the resources that FEDICE provided (\$ 1,000), I have planted onions.

I bought 15 loads of onion at \$20 each. I also invested funds to pay for a day's work: a tractor to prepare the land and two people to plant. I will plant more onions in another field that is still being prepared. Thanks to God and FEDICE, the resources have helped us a lot."

1. Monthly training with topics according to the technical needs of the Project.

In 2019, FEDICE began collaborating with women in Planchaloma. They formed a group, known as "Virgen del Cisne" and once formed, FEDIC started to provide training lessons on holding meetings as a microcredit group, how to share the results of their obligations, and the rights each individual has as a member. In an effort to focus on increasing livestock productivity, FEDICE also began teaching women in Planchaloma how to apply minerals and vitamins, as well as recognizing an animal's physiological

characteristics. Having women in the group who are qualified in these areas has resulted in a cost savings, since it was not necessary to hire an additional party for these purposes.

2. Generation of financing sources through the re-investment of resources.

The resources that the families received from FEDICE are paid out every four months for the members. These loans are paid back after one year, and resources are loaned again between themselves, so that they form their operating capital in such a way that they can access new loans for investments. The microcredit group in Planchaloma today has \$1,642.47 of capital.

3. Correction of weaknesses and strengthening of advantages through periodic monitoring and participatory evaluations.

The biggest problem that new members face is accessing credit in conditions that allow them to earn a profit, when sometimes the results of agricultural activity are delayed. For this reason, FEDICE worked with the treasurer of the group to set a maximum value of capital (i.e., \$200), the term (i.e. three months), and how to verify compliance with the loan objective (i.e., purchase of grass, vaccines, etc.). Unlike banks that begin intensive collection management when there is a payment default, the microcredit group treasurer establishes a line of communication with the debtor, and together they find a solution to the problem. This new process has been resulting in the repayment of the loan and the elimination of the psychological anguish that occurs in the person for not being able to comply with the payment upon the deadline.

4. Training and monitoring of activities, by the technical team of FEDICE.

So far, through the Planchaloma microcredit group, FEDICE has had over 30 meetings (16 face-to-face and 14 virtual). During this time, the meetings have focused on developing their projects, recovering funds, discussing any problems that members are facing, delivering new funds to the members, and verifying the purchase of animals.

The project design is developed jointly between FEDICE and the microcredit group in Planchaloma. Throughout this process, the following best practices have been discovered.

1. Women who produce and select their income-generating activity generate better results.

Women are able to use their capital to raise chickens and cows, plant and grow onions, or start a small shop. FEDICE does not impose the type of project; they guide microcredit members on how to decide what to start based on the resources and knowledge they have.

2. Sustainability of the project through the participation of women from planning, operation and financing.

The process developed by FEDICE is aimed at "the creation of human talent to be capable of executing

administrative, organizational, and productive operations by themselves." For this reason, FEDICE continually trains microcredit groups in a practical and theoretical way. On the other hand, the projects are financed by women and FEDICE. Women, therefore, create a sense of belonging to the project. Ultimately, women understand that saving money will help them have their own capital to work with and this creates a positive effect on reducing financial dependence on banks and cooperatives.

Including the cost of each participant's labor and work on their projects, the total budget for this two-year project is \$91,314. Of this total, \$20,000 was financed by FEDICE, including the \$8,000 provided by the sustainable development grant from Week of Compassion.

The grant of \$8,000 was distributed among 20 families for an initial loan of \$1,000 for each family. Our institution will finance the remaining \$12,000. Each family decided what type of project to begin with this initial loan. Of the families from Planchaloma, eleven (11) families began raising cattle and providing the necessary shots and medications, four (4) families began raising sheep, and five (5) families began small shops to sell items such as stationary, internet, diapers, clothes, or agricultural products.

Items under Investments, Raw Materials, and Merchandise attributed to the microcredit group in Planchaloma (\$55,484) includes the purchase of vaccines, de-wormers, vitamins for cows, rent payment, and basic services for businesses.

The value of each family's labor (\$11,130) corresponds to the daily care of an animal or crop and customer service.

Technical assistance (\$4,500) corresponds to the sum of all expenses for administration, monitoring, training, and evaluation of the project while they are ongoing.

Selling expenses (\$200) are the values paid for transportation of the different products.

In the original proposal, the grant was to be used for \$6,800 in microcredit loans and \$1,200 for technical training, transportation, and administration. Instead, the cost of technical training, transportation, and administration were covered through the interest of repaid loans, and the full \$8,000 was used to provide the initial loans to the 20 participating families.


